


Counties and Nation-States across America are once again forming “Jural Assemblies” to take a stand for We the People who will restore our lawful government.

Are you a US Citizen?

- From the standpoint of the Federal Government, a "US citizen" is a citizen of "the territories and District of Columbia" (10 square miles)-- -- and has been since June 30, 1863. [article 626].
- Those employed as federal civilian and military personnel are considered "US citizens" and also political asylum seekers, African Americans (who were never granted State Citizenship), welfare recipients as well as people born in Puerto Rico, people from Guam, American Samoa and the American Virgin Islands.
- If you hold a political office or are a federal employee, you are a US citizen.
 - If you are none of the above, then you are **not** a US Citizen, and you are not obligated to pay Federal Taxes.



Peace or war flag?

The Peace Flag

- This is our real flag, the flag of the American People



- The flag with fringes (shown on the right) represents jurisdiction of the sea and maritime admiralty law (British law) under which our court systems, **the military court**, operate.
- It is not the flag of the American people. Here shown in the oval office!
- It is the American flag of war.
- **The courts are at war with the People.**
- Citizens have been declared 'enemy of the state'



Flags are symbols with great significance!

- The STRAWMAN is considered a vessel 'lost at sea'.
- When walking into a courtroom, the military flag lets you know that you have entered sea jurisdiction.
- The British-controlled vessel is docked on our shores, on land (physical court) and is there to administer (make \$) via contracts.
- Anything else than "I am here to settle this matter and clear my good name" allows you to contract with the court, get on their ship, as well as when hiring an attorney with a Bar Association card to practice law (BAR = British Accreditation Registry).
- Contracts bring you onto their ship with little chance of winning due to 8 miles-long of Codes and Statutes designed to penalize (\$) the STRAWMAN.

Evidence of Vatican & British control via flags


Air force flag = Vatican control of the air.





Explanation of National Federation of States Assemblies

- The National Federation of States Assembly is called the Continental United States.
- It is comprised of 50 geographically defined nation-states acting as a federation operating “as” a nation on the land jurisdiction.
- This is the United States belonging to the "free, independent and sovereign people of the United States" described in The Definitive Treaty of Peace, Paris, 1783.

[Article 1294]

Explanation of National Federation of States Assemblies

- There has been no Continental Congress since 1860 competent to actually enroll the States created by Statehood Compacts.
- There hasn't been a "Land Congress" since 1860.
- Up until then, Delegates represented us in a Fiduciary capacity. They acted on behalf of the Land Jurisdiction; they met in Philadelphia. **We have had no representation in 150 years.**
- Washington DC, the District of Columbia, is a Corporation, its own 'country' and is not representing **people**.




Did You Know that.....Foreign Corporations Masquerade as your Government?

1863 – Lincoln declares the Northern States of States, the **federal "United States of America"** bankrupt. [Article 1259]

1868 - A Scottish Commercial Corporation was set up creating a British Territorial United States doing business as **"The United States of America, Incorporated"**. It was chartered by the Scottish Government, not the American Government.

1907 - The Scottish Commercial Corporation, **"The United States of America, Incorporated"**, declared bankruptcy.

Did You Know that.....Foreign Corporations Masquerade as your Government?

1925 - The Papacy oversaw the Roman Catholic Church and the Office of the Roman Pontiff set up a Delaware Corporation doing business as the
“United States of America, Inc.”

[Article 1513]

The Scottish usurper called itself **“The (federal) United States of America”** and the Roman Catholic version called itself **“the (MUNICIPAL) United States of America, Inc.”**

Both Corporations were fraudulent, unauthorized, criminal and foreign governments to us.



Did You Know that.....Foreign Corporations Masquerade as your Government?

1933 – This MUNICIPAL Corporation ran up bills against our remaining assets (belonging to **We the People**) when our land had already been seized upon as a security for the debts of the Scottish corporation.

They played hard and fast and bankrupted
"the" United States of America, Inc.
and then changed the name of the country to
THE UNITED STATES, INC.



Did you know?

Common Law Replaced with British Equity Law

- **1954** – Common Law was replaced with British Equity Law known as the ‘color of law’ or corporate law. Thus the takeover of the American Courts was complete.
- Corporate law is not for the people and is unlawful. It only pertains to CORPORATIONS. People are not corporations.
- There is no justice, only administrative codes and statutes designed to extract fees and fines from your **STRAWMAN = CORPORATE ENTITY** presumed to be you because of your Birth Certificate.
- Walking into a court is like walking into a Casino. It is all rigged against you!
- **Why would People ever go to their courts?**



Chapter 7 bankruptcy = liquidation

- **2015-2016** - President Obama bankrupted the MUNICIPAL United States Corporations and thereby they vacated the MUNICIPAL UNITED STATES GOVERNMENT Chapter 7 bankruptcy: it's time for liquidation.

This is why your homes, property, business profits, retirement funds, etc. have been stolen to pay off the debts. However, there was not enough to pay off the debts of the MUNICIPAL United States Government.



Chapter 11 bankruptcy = reorganization

- **2017** - The federal territorial United States Government could not cover both its own debt and the Municipal debt. As such, the Federal Territorial United States Government was forced to go into Chapter 11 bankruptcy to REORGANIZE.

The visible proof is that the government is taking over [selling off] the land and wealth in the ground throughout America. For instance The Uranium One deal, copper, gold & precious mineral mines selling to the highest bidder, exporting our extra oil production, selling off our national parks and other national treasures to other countries.

[Articles 1205, 1259]

The bottom line: the government is unable to function until the creditors, the trustees are satisfied with the new contracts.

- Most recently the government has renamed the corporations functioning as
"The United States Of America, Inc."
and they provide governmental services under the auspices of the
UNITED NATIONS CORPORATION - which are
all private,
for profit,
foreign corporations
using semantic deceit (another name change) to carry on business as usual.



DeFacto Government

- **The United States, Inc. (federal) aka UNITED NATIONS CORPORATION**
- is a foreign corporation in the business of providing **your** governmental services --
 - hence the reason it is called a "de facto" government.
 - We need to wake up!
 - It is not lawful.
 - It is a **ONE WORLD ORDER GOVERNMENT** in progress!



Claiming our Power back

- Due to both the MUNICIPAL and federal bankruptcies, The Delegation of Power returns to those who authorized it in the first place --- to The United States of America [Unincorporated] and to our States of the Union whose power is derived from “We the people”.
- We are claiming our land back, our labor back and all of our other assets.
- We are going after the bankruptcy administrators who serve their Courts of Baal on our shores and attack our innocent people under “Color of Law” (Corporate Law).

Acknowledgement, Acceptance and Deed of Re-Conveyance

- Establishes the fact that you are a living soul, of sound mind and body from birth state soil to the present soil you live on.
- Re-conveys all names and NAMES from any presumption of being lost at sea and firmly establishing them on the soil.
- Releases you from any presumption that you have authorized to the Corporations(s) any Power of Attorney, Executorships, Guardianships or Agency Relationships and firmly establishes that you are the sole living owner, executor, beneficiary and agent of your name and estate since your 21st birthday.



Certificate of Assumed Name Benefit

- It is a very powerful document.
- It invokes your Common Law Rights, transfer of reserved name, and the filing of **NAME(S)** when business is conducted under an assumed name. It uses session laws to Transfer your **STRAWMAN NAMES** into your true estate of a **Living Man/Woman** standing on the soil of your domicile.
- It invokes the Article IV Remedy clause of the Cestue Que Vie act of 1666, which allows you to claim all of your assets, property, etc. free and clear of taxes, fees, liens or any other encumbrance.



Certificate of Assumed Name Benefit

- It contains your writ of Habeas Corpus to ensure that the court jurisdiction realizes that you are alive and must deal with the live person and not confuse you with your **STRAWMAN**.
- It puts the **CORPORATION** on Notice that their oath and bond will be liened if they violate your rights in any way.
- It also contains your Mandatory Foreign Sovereign Immunity Act which states that the **Living Soul** is a **Foreign Sovereign** owed all rights, guarantees, and protections of The Constitution for the united States of America.



Act of Expatriation & Oath of Allegiance

- Allows you to take control of your **STRAWMAN NAMES** and affirms that you are not a citizen of the **CORPORATION**.
- You repatriate the **STRAWMAN** to your lawful trade name as a man/woman standing on the soil of your state of domicile.



Foreign Sovereign Immunities Act

- Puts the **corporations** on notice that you are not any part of the Federal Territorial, or MUNICIPAL corporation or acting in that capacity in any way.
- That you are standing on the soil since your **nativity** under **Common Law** and are owed the **Law of Peace**.
- Any harm resulting from trespass upon these **vessels (you)** or the use of fictitious names or titles related to them shall be subject to full commercial liability and penalties: 18 USC 2333, 18 USC 1341 and 1342.



Cancellation of All Prior Powers of Attorney

- All prior Powers of Attorney granted by you (knowingly and unknowingly) are removed, canceled, and permanently revoked effective as of the date of signing.
- Removes all known and unknown Powers of Attorney as sometimes this can be embedded in documents or adhesion contracts.
- This is also included in the Deed of Re-Conveyance.



Additional Steps

Claim your **NAME** connected to **ANYTHING** ever registered **BY** you or registered **FOR** you!

- ✓ Birth Certificate
- ✓ Credit Bureaus & Bureau of Motor Vehicle
- ✓ Divorce decree
- ✓ Name change
- ✓ Any license such as Driver's license, Marriage license, Professional license
- ✓ Any permit such as fishing, conceal and carry a gun, etc.
- ✓ Any Certificate or Registration such as automobile (non-commercial).
 - All these **REGISTERED** in your **NAME** are connected to a **CORPORATION** making \$ off your good name.

Revoke Voter Registration

- Any state you ever had a Driver's license in potentially registered your name as a Voter (without your permission!)
- Contact each state and county where you registered for a Driver's license.
- Some states have their own forms while others require a letter from you.
- So, do your own research.



Revoke Election to Pay Taxes

- If you are NOT a US Citizen (on earlier slide).
- A letter is sent to each IRS Commissioner located at two different addresses.
- Respond to their FEAR letter to you if you receive such a letter.
- Proper completion of the Payment Coupon enclosed in their final correspondence.
